**FELONY COMPLAINT**

The undersigned is informed and believes that:

COUNT 1

On or about September 14, 2003, in the County of Los Angeles, the crime of MURDER, in violation of PENAL CODE SECTION 187(a), a Felony, was committed by AARON MICHAEL HAMMER, who did unlawfully, and with malice aforethought murder YETUNDE PRICE, a human being.

"NOTICE: The above offense is a serious felony within the meaning of Penal Code section 1192.7(c)."

"NOTICE: Conviction of this offense will require you to provide specimens and samples pursuant to Penal Code section 296. Willful refusal to provide the specimens and samples is a crime."

It is further alleged that said defendant(s), AARON MICHAEL HAMMER personally used a firearm, a handgun, within the meaning of Penal Code section 12022.53(b).

It is further alleged that said defendant(s), AARON MICHAEL HAMMER personally and intentionally discharged a firearm, a handgun, within the meaning of Penal Code section 12022.53(c).

It is further alleged that said defendant(s), AARON MICHAEL HAMMER personally used a firearm, a handgun, within the meaning of Penal Code section 12022.53(b).

On or about September 14, 2003, in the County of Los Angeles, the crime of POSSESSION OF FIREARM BY A FELON - TWO PRIORS, in violation of PENAL CODE SECTION 12021(a)(1), a Felony, was committed by AARON MICHAEL HAMMER, who did unlawfully own, possess and have custody and control of a firearm, to wit, handgun, the said defendant(s) having theretofore been duly and legally convicted of a felony or felonies, to wit:
