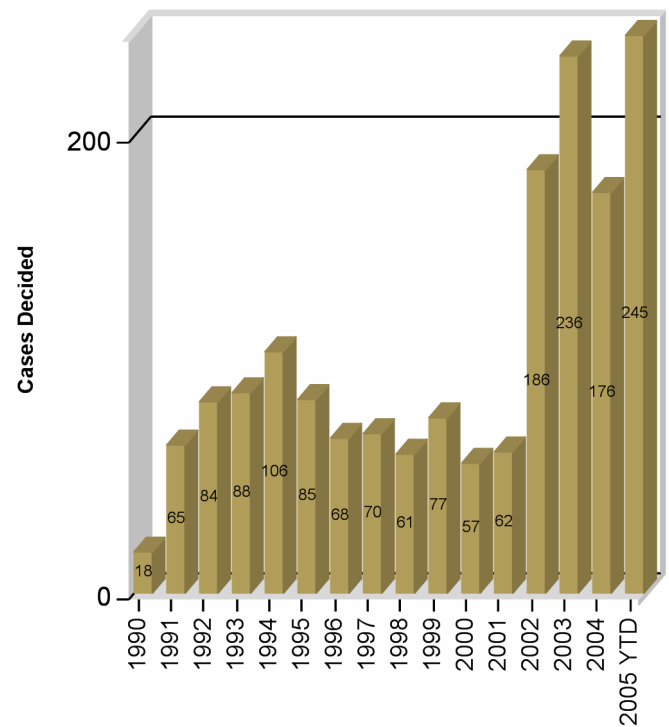

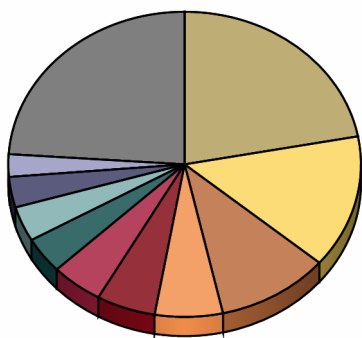

Practice Area / KeySearch™ Distribution



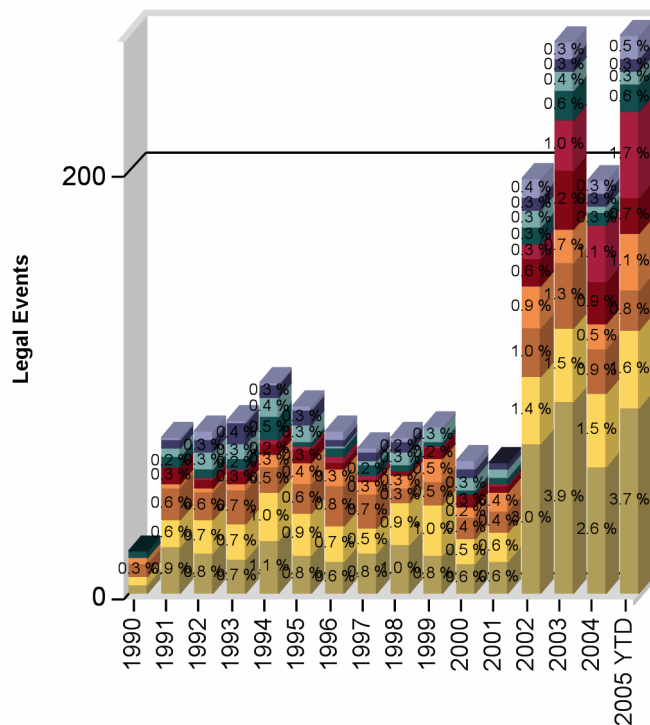

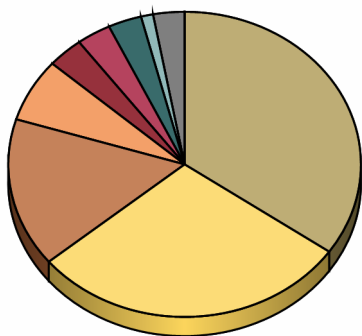

Legal Role Distribution



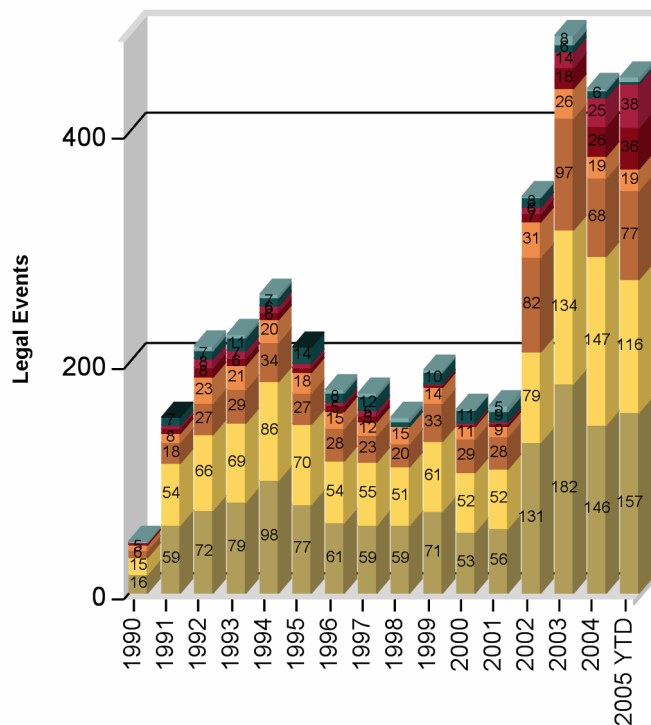

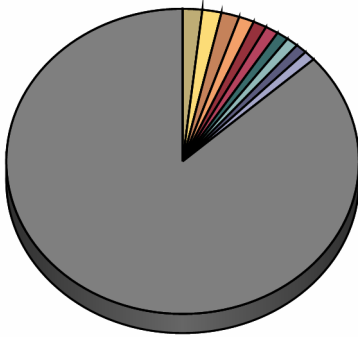

Law Firm Distribution



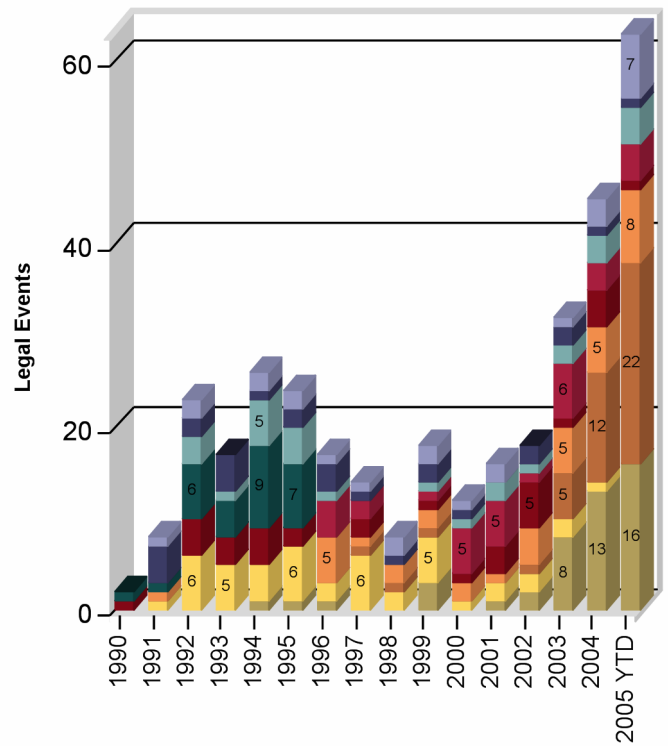

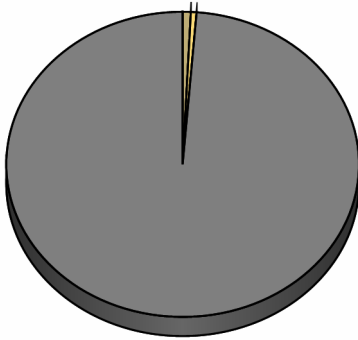

Attorney Distribution



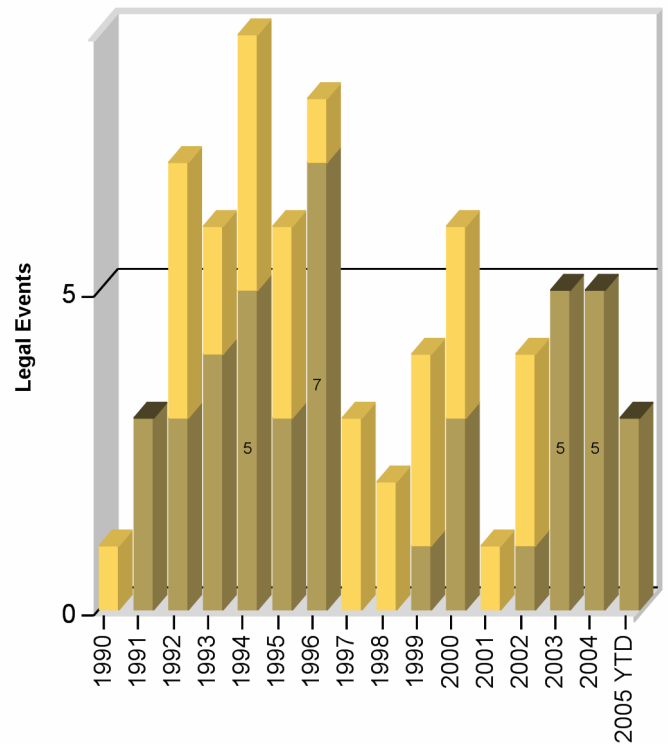

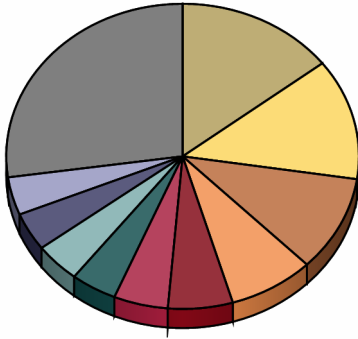

Industry Distribution



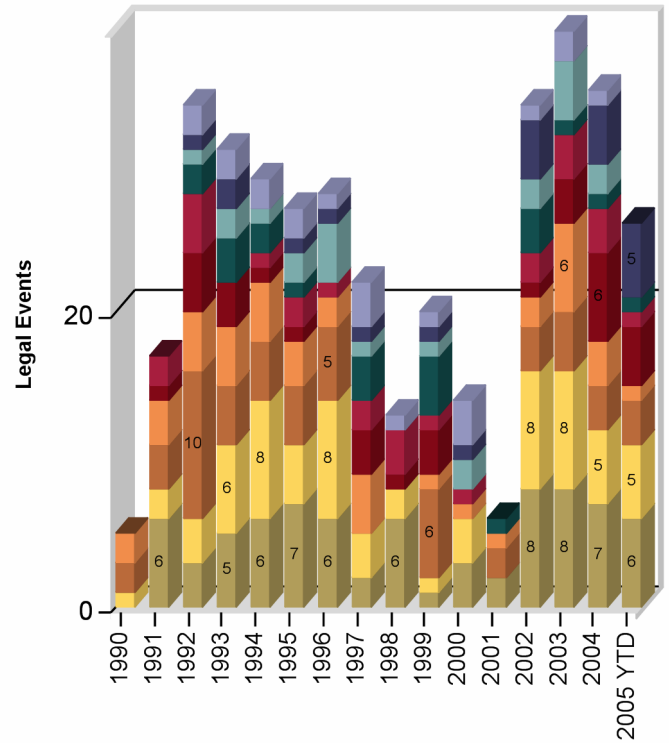

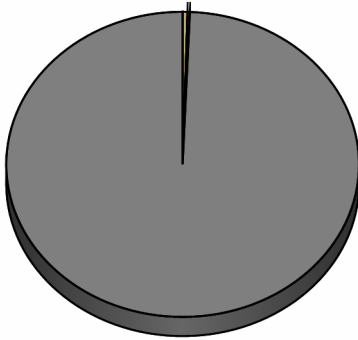

Company Distribution



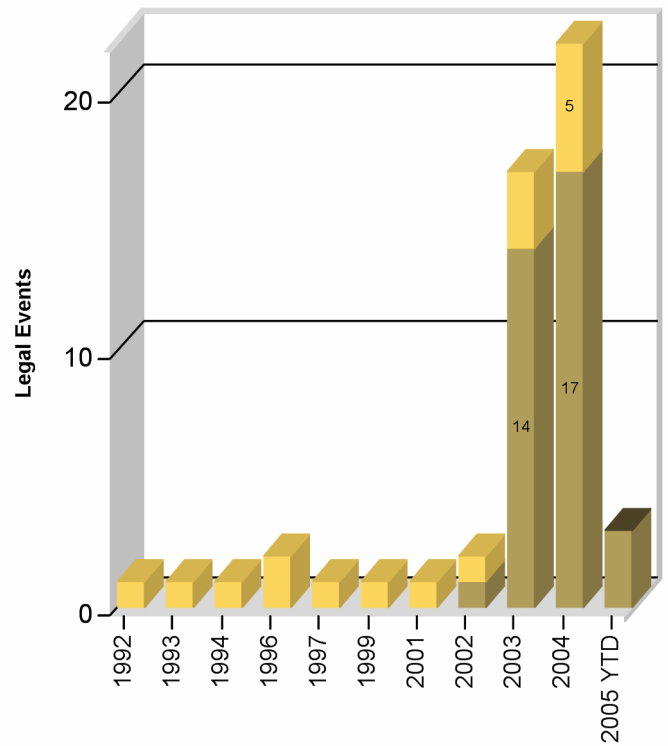

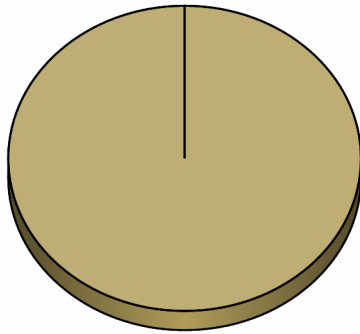

Federal Court Distribution



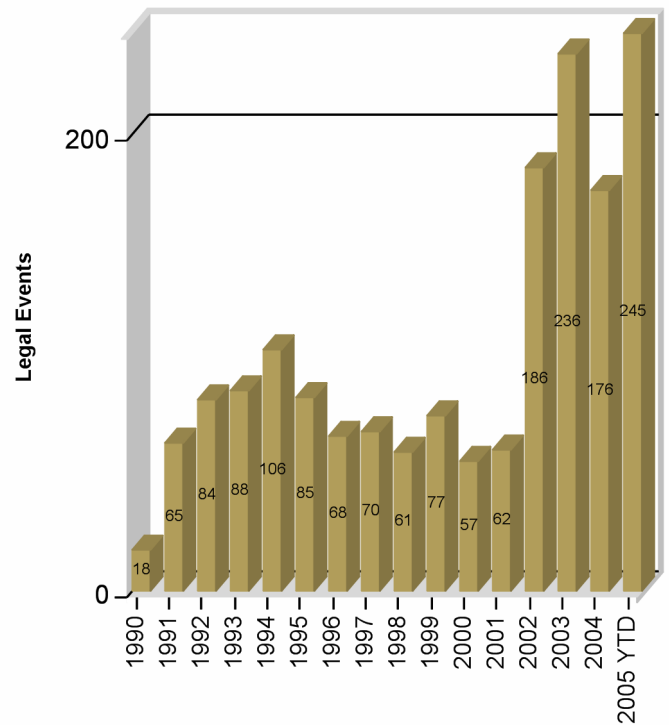
